

## AN ENERGY SOLUTION FOR AMERICA'S HEARTLAND

Families and businesses are facing rising costs and power grid operators are sounding the alarm about regional reliability challenges. Grain Belt Express is a regional electricity solution that will deliver billions of dollars in energy cost savings and greater reliability for consumers right here in the Midwest.

Grain Belt Express will deliver more power and savings locally including to 39 municipal utilities across Missouri and to rural communities, small towns, and cities across the Midwest. The project represents the equivalent of about four new nuclear power plants in transmission capacity to better meet regional energy needs. In addition to energy cost savings and reliability, Grain Belt Express will bring billions of dollars in economic investment to Kansas, Missouri, and Illinois, supporting workers, families, and communities.

### FOR LANDOWNERS: UPDATES AND WHAT'S AHEAD

Grain Belt Express recently announced a plan to deliver more power and energy savings benefiting more consumers throughout the Midwest. The project also plans to pursue construction in two phases, Grain Belt Express Phase 1 and 2, with Phase 1 moving ahead of Phase 2 to begin delivering local benefits sooner. For landowners, it is important to know which phase your parcels are part of. Each phase and the activities associated with them are detailed more below. All plans are subject to regulatory approvals.

### Phase 1 Route: Kansas to Northeast Missouri

#### Phase 1 includes:

- All land parcels in Kansas on the approved high-voltage direct current (HVDC) route.
- · All parcels in Missouri on the approved HVDC route from the Kansas-Missouri border to the Missouri converter station proposed in Monroe County.
- All parcels along the Tiger Connector delivery link proposed in Monroe, Audrain, and Callaway Counties in

#### Phase 1 status:

- · Along the approved HVDC route in Kansas and Missouri, landowner engagement and easement negotiations have been underway and are continuing.
- In January 2023, Phase 1 landowners and adjacent property owners should expect to receive notice from the U.S. Department of Energy regarding the start of the federal environmental review process for Grain Belt Express Phase 1.
- The Missouri Public Service Commission is currently reviewing Grain Belt Express's proposed Tiger Connector route. A final decision, including on the route, if approved, is expected in mid-2023.
- Grain Belt Express expects to begin outreach to Tiger Connector landowners in 2023.
- Surveys and engineering field work continue on Phase 1.

#### Phase 1 schedule:

Grain Belt Express will be ready to start full construction on Phase 1 by the end of 2024, pending regulatory

#### Phase 2 Route: Northeast Missouri to Indiana

## Phase 2 includes:

- · All land parcels on the approved HVDC route between the Missouri converter station proposed in Monroe County to the Missouri-Illinois border.
- All parcels along the Illinois route (pending approval).
- · All parcels along the Indiana approved route.

#### Phase 2 status:

- Along the approved HVDC route in Missouri, landowner engagement and easement negotiations have been underway and are continuing.
- The Illinois Commerce Commission is currently reviewing Grain Belt Express's Proposed and Alternate Routes. A final decision, including on the route, if approved, is expected in March 2023.
- Grain Belt Express expects to begin outreach to Illinois landowners in 2023.

#### Phase 2 schedule:

A schedule for Phase 2 has not yet been announced. Phase 2 will follow Phase 1, and we are fully committed to both phases of the project.

## **COMMUNITY GRANT PROGRAM**

We are committed to supporting route communities through meaningful and sustained engagement. As a result, Grain Belt Express established a community grant program to support local causes and initiatives along the route. These one-time, \$500 grants are evaluated and awarded quarterly.

Recipients of the Community Grant Program include: United Way of Greater St. Joseph in Missouri, supporting their annual campaign; West Union Community Fire Protection District in Illinois, helping purchase personal protective gear; and the Luray Community Foundation in Kansas, supporting a much-needed renovation for the historic Pospishil Building.

## **ENGAGING LOCAL SUPPLIERS**

Work is already underway to build a local supplier network needed to get a job like Grain Belt Express done. In July, PAR Electrical Contractors, headquartered in Kansas City, joined Grain Belt Express to host a supplier informational event in St. Louis. Representatives from 30 route-area and statewide supplier companies attended the event to learn more about the project.

At the event, Invenergy Transmission presented information about the services. scale, and resources needed to build this critically important energy project for our region and country.

Grain Belt Express means opportunity for suppliers, manufacturers, small businesses, and entrepreneurs throughout the Midwest. In all, it represents \$20 billion in new clean energy infrastructure between the line and new energy generation it will enable. This investment will support 22,300 direct construction jobs and \$2.5 billion in worker earnings during construction.
